THE EMPLOYMENT AGENCIES REGULATIONS, 1957

(Made by the Minister on the 7th day of November, 1957)

L.Nn. 254/57 Amdts:

- 1. These Regulations may be cited as the Employment Agencies Citation. Regulations, 1957.
- 2.—(1) Every person requiring a licence or the renewal of a licence shall apply to the Licensing Officer in the form set out as Form No. 1 in Schedule Schedule A. Α.
- (2) Every bond furnished to the Licensing Officer pursuant to section 8 of the Act shall be in the form set out as Form No. 2 in Schedule A and shall be in the sum of five hundred thousand dollars.
 - 3. The prescribed fee for the—
 - (a) grant of a licence, which includes authority for the placement of persons in employment-
 - (i) in Jamaica, shall be ten thousand dollars; and
 - (ii) outside Jamaica, shall be fifteen thousand dollars;
 - (b) renewal of a license, shall be five thousand dollars; and
 - (c) transfer of a licence, shall be eight thousand dollars.
- 4. Every application for the transfer of a licence to some other person shall be made to the Licensing Officer in the form prescribed in Schedule B.

Schedule B

5. Every application for the transfer of a licence to some other premises shall be made to the Licensing Officer in the form prescribed in Schedule C, Schedule C. and no fee shall be payable in respect of such transfer.

- 6.—(1) Every licence which includes authority for the placement of persons in employment outside Jamaica shall be in the form set out as Form Schedule D. No. 1 in Schedule D.
- (2) Every licence other than a licence referred to in paragraph (1) shall be in the form set out as Form No. 2 in Schedule D.

7. The Licensing Officer shall keep a register, to be known as the Register of Employment Agencies.

Schedule E

8. Every person holding a licence shall keep a record in the form prescribed in Schedule E, giving particulars of each person registered with his employment agency, and the fees collected from that person, and indicating how that person has been placed in employment.

Schedule F

- 9. Every holder of a licence shall make returns to the Licensing Officer in the form prescribed in Schedule F, showing the business conducted by him, so far as it relates to his employment agency, during the quarterly periods ending on the 31st day of March, the 30th day of June, the 30th day of September and the 31st day of December in each year. Every return shall be made in time to reach the Licensing Officer before the expiration of twenty-one days next after the end of the quarterly period to which the return relates
- 10.—(1) Subject to paragraph (1A), no employment agency shall charge for its services any fee which—
 - (a) in respect of registration for twelve months, exceeds two thousand five hundred dollars; and
 - (b) in respect of each placement of a client in employment in Jamaica, exceeds one-third of the wages paid to that client for his work during his first week in such employment;
 - (c) in respect of each placement of a client in employment outside Jamaica, exceeds forty-five thousand dollars.
- (1A) An employment agency shall not charge any fee to any person for his placement in employment in any programme which requires a H-2B visa issued by the Government of the United States of America or in any other programme for the placement of persons in employment outside Jamaica which prohibits the charging of fees to persons seeking placement in employment under that programme.

- (2) An employment agency shall refund not less than three-quarters of the fee paid for placement in employment outside Jamaica to any client who is refused permission to enter or work in the country in which that client wished to be placed in employment or whose application for such employment is refused or cancelled for any reason.
- 11. Every employment agency shall, not later than seven days after any client whom it has arranged to place in employment outside Jamaica executes the contract in respect of such employment, furnish the Licensing Officer with a certificate in the form set out in Schedule G as—

Schedule G

- (a) Form No. 1 where the employment is as a live-in household help; or
- (b) Form No. 2 where the employment is in any capacity other than as a live-in household help.
- 12. Except where penalties are otherwise provided for in these Regulations, every person who contravenes or fails to comply with the provisions of these Regulations shall on summary conviction thereof before a Resident Magistrate be liable to a fine not exceeding two hundred and fifty thousand dollars and in default of payment thereof, to imprisonment with or without hard labour for a term not exceeding three months.
- 13.—(1) An employment agency or a person who is the proprietor of or is otherwise concerned in the operation of, an employment agency, shall not place any person in employment outside Jamaica unless the person holds a certificate in the form prescribed in Schedule H to the effect that the Licensing Officer is satisfied as to the matters specified therein.
- (2) An employment agency that, or a person who, contravenes paragraph (1) commits an offence and is liable upon summary conviction in a Resident Magistrate's Court to a fine not exceeding two hundred and fifty thousand dollars or to imprisonment for a term not exceeding three months or to both such fine and imprisonment.
